
## Annex 1, Current and Previous Work experience

## Warnings about "Plagiarism"

## "Plagiarism" is a serious offense in academic field.

<u>Plagiarism</u> means using others' ideas and words without clearly acknowledging the source of that information.

University students including ABE Initiative applicants and fellows are members of the academic field, and must avoid the plagiarism in making a research plan and thesis. Otherwise, you may be disqualified from the selection, or even be discharged from the university, once the plagiarism is found in your research plan, or academic work in the university.

## Such cases are deemed as plagiarism:

- Copying from books or articles written by another author without full acknowledgement
- Copying from an internet source without attribution text or information
- Misrepresentation of someone's work as original work

## To avoid plagiarism, you must cite sources and give credit whenever you use:

- Another person's idea, opinion, or theory
- Any facts, statistics, graphs, drawings any pieces of information that are not common knowledge
- Quotation of another person's actual spoken or written words, or
- Paraphrase of another person's spoken or written words

When you make your research plan, also pay attention to "Paraphrase".

<u>Paraphrase</u> is a re-expression of another person's ideas in your own words. There is accurate and inaccurate way of paraphrasing.

Here are some websites for more explanation on those matters. Applicants must prepare research plan carefully to avoid plagiarism.


Passport copy to check nationality, name, sex, and date of birth.

National ID and birth certificate are acceptable if you do not have Passport.


Certified English translation must be attached if ID is not written in English, French, Portuguese or Spanish.

## University Diploma(Certificate) / Academic Transcript


- 1, The copied document of original one is approved only with the original notary seal affixed.
